

NOTE: NEW LAW TCA SECTION 2-7-133, JULY 1, 2003: Any person seeking to be elected in the City of LaVergne Election by write-in ballots must complete a notice requesting such person's ballots be counted no later than twenty (20) days before the election. **Such person shall only have write-in ballots counted if such notice was completed and timely filed at the Rutherford County Election Commission Office.** Such notices may be completed by the write-in candidate at the Rutherford County Election Commission Office located at #1 Public Square South, Room 103, Murfreesboro, TN.
