## NOTICE OF ELECTIONS STATE AND FEDERAL GENERAL ELECTION TOWN OF SMYRNA REFERENDUM NOVEMBER 7, 2006

Notice is hereby given that a **Federal and State General Election** will be held in all voting precincts of Rutherford County, Tennessee on November 7 2006, for the purpose of electing candidates seeking the following State and Federal Offices listed below. Voters will also be able to vote on Two State Constitution Amendment Issues: 1. Amendment #1 (marriage) 2. Amendment #2 (Property Tax Relief). Amendment #1 (Marriage). Passage of the amendment would define marriage as being between one man and one woman. Amendment #2 (Property Tax Relief). Passage of the amendment would allow, but not require, the legislature to implement a program of property tax relief for the persons sixty-five (65) years of age or older. Town of Smyrna Referendum will be held only in the Town Limits of Smyrna for the purpose of deciding by majority vote to allow or not to allow the sale of package Liquor.
